ACKNOWLEDGMENT OF AND ASSUMPTION OF RISK**

- 1) Skiers, snowboarders and ski lift passengers are governed by the New York State SAFETY IN SKIING CODE, Article 18 of the New York General Obligations Law.
- 2) BEFORE AFFIXING YOUR PASS or allowing your pass to be affixed to your person, your attention is directed to a posted "WARNING TO SKIERS" WHICH IS DISPLAYED At holiday Mountain ticket location and is reprinted below.
- 3) The safety in skiing code requires you to seek out, read and understand the "WARNING TO SKIERS" before you decide to participate in the sport of skiing.

We (the person or persons signing below), know that Alpine, Nordic and free-style skiing and snowboarding are action sports carrying significant risk of serious personal injury, death and property damage. We also know that there are natural and environmental conditions and risks independently or in combination with our activities, which may cause property damage or severe or even fatal injuries to others or us.

We agree that we are alone responsible for our safety while skiing, snowboarding, training, participating in competitive events, training for competitive events, and specifically acknowledge that the foregoing persons or entities, including the Town of Thompson, Holiday Mountain Fun Park Inc, Holiday Mountain Ski & Snowboard Club, the ski area, the promoters, the sponsors, the organizers, the promoter clubs, the officials and any agent, representative, officer, director, employee, member of affiliate of any/all person(s) or entity named above are not responsible for our safety. We specifically **RELEASE and DISCHARGE** in advance, those parties from any and all liability whether, known or unknown, even though that liability may arise out of negligence or carelessness on the part of any persons or entities mentioned above. We agree to accept all responsibility for the risks, conditions and hazards that may occur whether they now are known or unknown.

Being fully aware of the risks, conditions and hazards of the proposed activity as a participant/competitor, parent/guardian of a participant/competitor, coach or official, **WE HEREBY AGREE TO WAIVE, RELEASE AND DISCHARGE** any and all claims for damage for death, personal injury or property damage which we may have or which may hereafter accrue to us as a result of our or any other persons participation in club activities, competitive events or training for competitive events, against any person or entity mentioned above whether such injury or damage was foreseeable.

I grant permission to Holiday Mountain Fun Park Inc. to utilize any photograph, videotape, motion picture, recording or other record of any use of its facilities for any legitimate purposes.

We further agree to forever **HOLD HARMLESS and INDEMNIFY** all persons and entities identified above, generally or specifically, from any and all liability for death and/or personal injury or property damage resulting in any way from our participation in any way in club activities, competitive events or training for competitive events.

The undersigned as Parent/Guardian hereby consents to each child's participation in club activities, competitive skiing, snowboarding and training and acknowledges and understands that any and all risk, whether known or unknown, is expressly assumed by us and all claims, whether known or unknown are expressly waived in advance by the **ACKNOWLEDGMENT OF AND ASSUMPTION OF RISK AND RELEASE**.
